## JOINT CORRECTION NOTICE OF APPROVAL

On December 6, 2022, Palo Duro Service Company, Inc. (Palo Duro) and the City of Hudson Oaks (Hudson) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Parker County.

On December 5, 2024, the administrative law judge (ALJ) filed a Notice of Approval, approving the Applicants application. 16 Texas Administrative Code (TAC) § 22.35(c)(1) provides that any party may file corrections to a notice of approval within 15 days of the issuance of such notice. Therefore, this pleading is timely filed.

#### I. CORRECTION TO NOTICE OF APPROVAL

Staff and Applicants have reviewed the Notice of Approval and note that there is an error in Ordering Paragraph Number 7, which imputes Hudson's water services policies to Palo Duro. The parties respectfully request the reissuance of the Notice of Approval, with the below text replacing Ordering Paragraph Number 7:

"Palo Duro must provide service to every customer or qualified applicant for service within the approved area under CCN number 12200 that requests water service and meets the terms of Palo Duro's water service policies, and such service must be continuous and adequate."

#### II. CONCLUSION

For the reasons discussed above, the parties respectfully request the ALJ reissue the Notice of Approval with the modified Ordering Paragraph Number 7 above.
