To whom it may concern,


I live in Clear Water Estates Subdivision (CWE) in Canyon Lake, TX. I protest this water rate increase based on the following:

- Clear Water Estates water system is completely separate from the Canyon Lake Water System
- Your letter mentions 1.25 million gallons of Storage. This does not impact CWE boundaries as we have our own storage. A mute point.
- There have been no Backup power Generators installed in CWE boundaries. Another mute point.
- There have been no plant expansion in CWE boundaries.
- The 8 miles of transmission line have not been for CWE. Another mute point.
- Adding Electronic meter readers saves SJWTX money so we should get a rate reductions there are no longer meter readers.

Based on the above, I ask that a rate increase not be instituted.
