
MXE continues to rely upon its Shareholders' Equity and Letter of Credit that is on file with the Commission. Financial statements from MXE are included with this report in Attachment B.

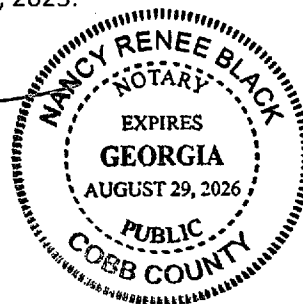
