OHMCONNECT TEXAS, LLC'S 2023 SEMI-ANNUAL REPORT

OhmConnect Texas, LLC ("OhmConnect") submits its semi-annual report for 2023 pursuant to 16 Tex. Admin. Code (TAC) § 25.107(i)(5)(B). OhmConnect additionally submits the attestation of Laura Persson, General Manager of OhmConnect Texas, LLC, attesting to the facts represented herein. OhmConnect provides the following information as required under the rule. OhmConnect is electing to use the previous version of 16 TAC § 25.107 as allowed by Public Utility Commission of Texas ("PUCT") Staff in its August 6, 2023 Semi-Annual Report Instructions for Retail Electric Providers ("REP") who were certified prior to April 26, 2023.

1. Documentation to demonstrate ongoing compliance with the financial requirements of subsection (f) of this section. (16 TAC § 25.107(i)(5)(B)(i)).

a. Financial Requirements (16 TAC § 25.107(f)(1).

OhmConnect relies upon the investment grade credit rating of its guarantor to demonstrate compliance with the financial requirements under the rule and attaches the latest ratings from Moody's, Standard & Poor's, and Rating and Investment's credit rating agencies. These are copyrighted materials and are therefore being submitted confidentially and under seal. Further, OhmConnect also provides the unaudited financials of its guarantor confidentially and under seal.

b. The amount of customer deposits and the balance of an account in which customer deposits are held (16 TAC § 25.107(f)(2)(B)).

OhmConnect maintained customer deposits of a confidential amount set forth in an attachment provided under seal. OhmConnect also attaches under seal its customer deposit

balance sheet to demonstrate its compliance with 16 TAC § 25.107(f)(2)(B). This information is submitted confidentially as an attachment to this filing. Further, use of the July 31, 2023 deposit bank account statements complies with the requirements of 16 TAC § 25.107(i)(5)(B)(i) that "[a]ny certified calculations provided as a part of the semi-annual report to demonstrate such compliance shall be as of the end of the most recent fiscal year and most recent fiscal quarter."

2. The audited financial statements of the REP or its guarantor for the most recent completed calendar or fiscal year (16 TAC § 25.107(i)(5)(B)(ii)).

OhmConnect confidentially submits its audited financial statements for the year ending December 31, 2022. OhmConnect is not publicly traded, so these statements are accordingly filed under seal.

3. The un-audited financial statements for the most recent six-month financial period that immediately follows the end of its most recent fiscal year or six consecutive months of monthly financial statements (16 TAC § 25.107(i)(5)(B)(iii)).

OhmConnect submits its unaudited financial statements for the first six months of 2023, under seal.
