## **ORDER APPROVING ERCOT ADMINISTRATIVE REVISION REQUESTS**

This Order addresses seven Administrative Revision Requests to Electric Reliability Council of Texas (ERCOT) protocols. If no comments are submitted within ten business days of posting on ERCOT website, Administrative Revision Requests do not go through the stakeholder process, but still require Commission approval.<sup>1</sup> The Commission approves these revisions and accompanying market impact statements.

- Administrative Commercial Operations Market Guide Revision Request (COPMGR) 050, Administrative Change for Commercial Operations Market Guide – *Remove Obsolete Reference from List of Appealable TAC Actions;*
- Administrative Load Profiling Guide Revision Request (LPGR) 073, Administrative Change for Load Profiling Guide – *Remove Obsolete Reference from List of Appealable TAC Actions;*
- Administrative Nodal Operating Guide Revision Request (NOGR) 260, Administrative Change for Nodal Operating Guide – *Remove Obsolete Reference from List of Appealable TAC Actions;*
- Administrative Retail Market Guide Revision Request (RMGR) 175, Administrative Change for Retail Market Guide – *Remove Obsolete Reference from List of Appealable TAC Actions;*
- Administrative Resource Registration Glossary Revision Request (RRGR) 037, Administrative Change for Resource Registration Glossary – *Remove Obsolete Reference from List of Appealable TAC Actions;*
- Administrative Settlement Metering Operating Guide Revision Request (SMOGR) 029, Administrative Change for Settlement Metering Operating Guide – *Remove Obsolete Reference from List of Appealable TAC Actions;* and
- Administrative Verifiable Cost Manual Revision Request (VCMR) 038, Administrative Change for Verifiable Cost Manual – *Remove Obsolete Reference from List of Appealable TAC Actions.*

On November 8, 2023, ERCOT filed ERCOT Market Impact Statements. These supporting ERCOT documents constitute the market impact analysis. Commission Staff filed a memorandum on December 7, 2023, related to these revisions in which it recommends that the Commission approve these revisions to the protocols.

The Commission finds that these revisions to the ERCOT protocols are necessary for the proper functioning of the ERCOT market as demonstrated by the supporting material. The Commission issues the following orders:

1. The Commission approves COPMGRR050 and accompanying market impact statement.
2. The Commission approves LPGRR073 and accompanying market impact statement.
3. The Commission approves NOGRR260 and accompanying market impact statement.
4. The Commission approves RMGRR175 and accompanying market impact statement.
5. The Commission approves RRGRR037 and accompanying market impact statement.
6. The Commission approves SMOGRR29 and accompanying market impact statement.
7. The Commission approves VCMRR038 and accompanying market impact statement.
