

CY 2023 REVIEW OF RULES \$ PUBLIC UTILITY COMMISSION ADOPTED BY THE INDEPENDENT \$ OF TEXAS

ORDER APPROVING ERCOT REVISION REQUESTS

This Order addresses nine proposed revisions to Electric Reliability Council of Texas (ERCOT) protocols. The Commission approves these revisions and accompanying market impact statements.

At its meeting on December 19, 2023, the ERCOT Board of Directors (Board) recommended Commission approval of the following nine proposed revisions:

- NPRR1172, Fuel Adder Definition, Mitigated Offer Caps, and RUC Clawback;
- NPRR1181, Submission of Seasonal Coal and Lignite Inventory Declaration;
- NPRR1192, Move OBD to Section 22 Requirements for Aggregate Load Resource Participation in the ERCOT Markets;
- NPRR1196, Correction of NCLR Ancillary Service Failed Quantity Calculations under NPRR1149;
- NPRR1201, Limitations on Resettlement Timeline and Default Uplift Exposure Adjustments;
- NPRR1204, Considerations of State of Charge with Real-Time Co-Optimization Implementation;
- NOGRR257, Removal of Redundant ERS Reporting Requirement;
- PGRR110, Revision to Accommodate Steady-State Node-Breaker Modeling; and
- RMGRR176, Addition of Market Processes Specific to LP&L.

On December 27, 2023, for each proposed revision, ERCOT filed a copy of its Board Report, which includes an ERCOT Market Impact Statement, and ERCOT Impact Analysis. These supporting ERCOT documents constitute the market impact analysis. Commission Staff filed a

memorandum on January 25, 2024, related to these revisions in which it recommends that the Commission approve the revisions.

The Commission finds that the revisions to the ERCOT protocols are necessary for the proper functioning of the ERCOT market as demonstrated by the supporting material. The Commission issues the following orders:

- 1. The Commission approves NPRR1172 and accompanying market impact statement
- 2. The Commission approves NPRR1181 and accompanying market impact statement.
- 3. The Commission approves NPRR1192 and accompanying market impact statement.
- 4. The Commission approves NPRR1196 and accompanying market impact statement.
- 5. The Commission approves NPRR1201 and accompanying market impact statement.
- 6. The Commission approves NPRR1204 and accompanying market impact statement.
- 7. The Commission approves NOGRR257 and accompanying market impact statement.
- 8. The Commission approves PGRR110 and accompanying market impact statement.
- 9. The Commission approves RMGRR176 and accompanying market impact statement.
