**ORDER NO. 2**  
**CONSOLIDATING DOCKETS AND CLOSING DOCKET**

On December 12, 2022, in Docket No. 54459, Megan Estes dba Big Creek West Water Supply filed an application for a class D rate adjustment for the Big Creek West Water Supply public water system under certificate of convenience and necessity (CCN) number 13282. On December 19, 2022, in Docket No. 54500, Megan Estes dba Cedar Creek Water Supply filed an application for a class D rate adjustment for the Cedar Creek Water Supply public water system under CCN number 13282.

On December 20, 2022, Order No. 2 in Docket No. 54459 and Order No. 1 in Docket No. 54500 was filed. In these Orders, the administrative law judge notified all parties of his intent to consolidate Docket Nos. 54459 and 54500 into a single docket, Docket No. 54459. No party objected to the proposed consolidation.

The ALJ consolidates Docket Nos. 54459 and 54500 into a single docket, Docket No. 54459. All future filings will be made only in Docket No. 54459, which is restyled as follows: *Application of Megan Estes for a Class D Rate Adjustment*. So that the record in both matters will be complete, the ALJ deems all documents filed prior to the date of this Order on the Commission's interchange in Docket No. 54500 to be incorporated by reference and also part of the record for Docket No. 54459. Docket No. 54500 is hereby closed.

By January 30, 2023, Commission Staff must file a supplemental recommendation on the administrative completeness of the applications and notice and propose a procedural schedule, if appropriate.
