**ORANGE COUNTY WATER CONTROL & IMPROVEMENT DISTRICT NO. 1'S
SUPPLEMENTAL FILING TO ITS PETITION TO AMEND ITS CERTIFICATES OF
CONVENIENCE AND NECESSITY IN ORANGE COUNTY**

COMES NOW, Orange County Water Control and Improvement District No. 1 (Applicant) files this Supplemental Filing to its Petition to Amend its Certificates of Convenience and necessity and would show the following:

I. BACKGROUND

Applicant filed an application to amend its certificates of convenience and necessity in Orange County in order to cure a discrepancy in the CCN mapping in the Public Utility Commission records. Since 2023, Applicant has been working to amend its CCN to include the area formerly served by Lexington Water System. On September 1, 2023, Applicant filed a memorandum from its engineer detailing the area and customer connections in the area to be included in the CCN. Thereafter, Applicant has continued to work with its engineer to confirm the customer connection count is correct prior to mailing the required notices.

II. SUPPLEMENTAL BRIEFING AND REQUEST FOR AN EXTENSION

The Applicant has owned Lexington Water System since 1995 and 1994, respectively and has provided water and/or sewer service to the customers in both areas since the time of purchase. This STM application is only a housekeeping matter in order to ensure this area, that the Applicant already serves, is included in its CCN. Applicant is continuing to work to confirm the correct number of notices that must be mailed out to comply with Order No. 18. Currently, Order No. 18 requires applicant to file with the Commission signed affidavits that the notice was given along with a copy of the notice and map sent to the affected parties. Applicant respectfully requests an additional thirty (30) day extension to confirm the number of notices to be sent to customers affected by the amendment since the customer connections are

already currently being served by the Applicant. Applicant has corresponded with Staff and Staff is not opposed to an additional thirty (30) day extension.

III. CONCLUSION

Applicant respectfully requests the ALJ grant the Applicant a thirty (30) day extension to confirm the customers affected by the amendment and send out proper notices.
