**ORDER NO. 20
FINDING NOTICE REMAINS DEFICIENT
AND AMENDING PROCEDURAL SCHEDULE**

In Order No. 14 filed on June 14, 2024, the administrative law judge (ALJ) set July 17, 2024, as the deadline for the applicants to file proof of notice of the application to affected parties. The applicants did not file proof of notice or otherwise respond to Order No. 14.

In Order No. 15 filed on August 1, 2024, the ALJ found notice deficient and set August 19, 2024, as the deadline for the applicants to file proof of notice. The applicants did not file proof of notice or otherwise respond to Order No. 15.

In Order No. 16 filed on September 6, 2024, the ALJ found notice remained deficient and set September 27, 2024 as the deadline for the applicants to file proof of notice. The applicants did not file proof of notice or otherwise respond to Order No. 16.

In Order No. 17 filed on October 14, 2024, the ALJ found notice remained deficient and set November 12, 2024, as the deadline for the applicants to file proof of notice. On November 11, 2024, the applicants filed a request for an extension of its deadline to file proof of notice. In Order No. 18 filed on November 13, 2024, the ALJ granted the applicants' request for an extension and set December 12, 2024, as the deadline for the applicants to file proof of notice.

On December 3, 2024, the applicants filed proof of notice.

On January 13, 2025, Commission Staff filed a supplemental recommendation on the sufficiency of notice.

In Order No. 19 filed on January 21, 2025, the ALJ found the notice remained deficient and set February 10, 2025, as the deadline for the applicants to file proof of supplemental notice.

On March 10, 2025, Commission Staff filed a supplemental recommendation on the sufficiency of notice.


The ALJ finds the notice remains deficient and requires the applicants to provide supplemental notice as described in Commission Staff's January 13, 2025 recommendation.

The ALJ amends the procedural schedule as follows:

Event	Date
Deadline for the applicants to file with the Commission signed affidavits that supplemental notice was given along with a copy of the notice and map sent to the affected parties	April 21, 2025
Deadline for Commission Staff to file a recommendation on sufficiency of the supplemented notice	May 21, 2025
Deadline to intervene	30 days after notice is issued
