**JOINT REQUEST FOR EXTENSION**

On December 16, 2022, Forest Glen Utility Company (Forest Glen) filed an application to amend its sewer certificate of convenience and necessity (CCN) number 21070 in Medina County, Texas under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Forest Glen supplemented the application on December 19, 2022, February 16, 2023, March 2, 2023 and March 3, 2023, and filed Proof of Mailed Notice and Publication on April 20, 2023.

On March 20, 2023, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice, along with a proposed procedural schedule by May 8, 2023.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff is working with the Applicants to resolve several mapping issues and hope to resolve these issues prior to a recommendation on sufficiency of notice. Staff has conferred with Applicants and to allow enough time for Staff and the Applicants to resolve all issues and for Staff to review all maps once they are provided, Staff respectfully requests an extension of time to May 31, 2023, to file its recommendation regarding the administrative completeness of the application and proposed notice, along with a proposed procedural schedule.

**II. CONCLUSION**

Staff respectfully requests the entry of an order consistent with the above request for extension.
