#### SECOND UNOPPOSED REQUEST FOR EXTENTION

COMES NOW Forest Glen Utility Company (Applicant or Forest Glen) and files this Second Unopposed Request for Extension. In support thereof, Forest Glen would show the following:

#### I. BACKGROUND

On December 16, 2022, Forest Glen filed an application to amend its sewer certificate of convenience and necessity (CCN) No. 21070 in Medina County. On June 29, 2023, the Commission Administrative Law Judge (ALJ) issued Order No. 6 finding notice deficient and requiring re-notice by July 28, 2023. Therefore this pleading is timely filed.

### **II.** MOTION FOR EXTENSION

Order No. 6 found Applicant's notice to be deficient because it utilized maps that had not been found administratively complete. Applicant revised its notice maps and paid the newspaper of general circulation in the county where the proposed amended CCN is being requested to publish the revised notice. The Hondo Anvil Herald published the first running of the revised notice on July 20, 2023. The second publication was due to occur today July 27, 2023. However, according to the publisher, they overlooked the second publication by mistake. Commission rule 16 Tex. Admin. Code ("TAC") § 24.235(c) requires that the notice be published for two consecutive weeks.

Accordingly, pursuant to 16 TAC § 22.4(b), Applicant seeks a 30-day extension so that it may re-publish notice, including the administratively complete maps, for two consecutive weeks. Applicant has conferred with the Commission Staff who are unopposed to this extension, which is not sought for delay but in good faith due to circumstances beyond its control.

### III. PRAYER

WHEREFORE, PREMISES CONSIDERED, Forest Glen respectfully prays that the

Commission ALJ issue an Order granting a 30-day extension for the purposes of republication of revised notice, and for all other relief to which it is entitled.
