#### **COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON NOTICE**

On December 16, 2022, Forest Glen Utility Company (Forest Glen) filed an application to amend its sewer certificate of convenience and necessity (CCN) number 21070 in Medina County, Texas under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Forest Glen filed supplemental information on December 19, 2022, February 16, 2023, March 2, 2023, March 3, 2023, May 30, 2023, and August 28, 2023.

On September 12, 2023, the administrative law judge (ALJ) filed Order No. 8, directing Forest Glen to provide proof of re-issued notice to landowners, neighboring utilities, and affected parties, which include the correct maps, by September 22, 2023, and the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on notice by October 6, 2023. Therefore, this pleading is timely filed.

#### I. SUPPLEMENTAL RECOMMENDATION ON NOTICE

Forest Glen has late filed proof of re-issued notice to landowners, neighboring utilities, and affected parties, which included amended maps. Though the filing was late, the notice was timely, therefore, Staff recommends that notice is sufficient.

#### **II.** CONCLUSION

Staff respectfully requests the entry of an order consistent with these recommendations.
