JOINT REQUEST FOR EXTENTION

COMES NOW Staff of the Public Utility Commission of Texas (Commission) and Forest Glen Utility Company (Applicant or Forest Glen) (collectively, the Parties) and file this Joint Request for Extension. In support thereof, the Parties would show the following:

I. BACKGROUND

On December 16, 2022, Forest Glen filed an application to amend its sewer certificate of convenience and necessity (CCN) No. 21070 in Medina County. On October 23, 2023, Commission Staff filed their First Request for Information (RFIs) seeking certain information from Applicant by November 13, 2023. On November 7, 2023, the Commission Administrative Law Judge (ALJ) issued Order No. 10 entering a procedural schedule, including a deadline for Commission Staff to file final maps, certificates, and tariffs as applicable by November 16, 2023. Therefore this pleading is timely filed.

II. MOTION FOR EXTENSION

Commission Staff's RFIs imposed a 20-day deadline on Applicant to provide certain financial information before their final map, certificate and tariff are otherwise due, one week later. However, the RFIs required the collection of certain documentation from Applicant's affiliate for which Applicant needs additional time. Commission Staff was unopposed to Applicant's request for additional time for this purpose. However, delaying the deadline for RFIs would force Commission Staff to miss its deadline to provide final documents under the Order No. 10 schedule. In other words, the RFI delay, in turn, triggers the need for an extension to the other remaining dates in Order No. 10.

Therefore, in accordance with title 16 Tex. Admin. Code § 22.4(b), in order for Applicant to obtain and Commission Staff to thoroughly review the requested discovery, the Parties propose an extension to all remaining deadlines in the Order No. 10 schedule as follows:

Deadline for Forest Glen to respond to Staff's RFI	December 11, 2023
Deadline for Commission Staff to file final maps, certificates, and tariffs	December 18, 2023
Deadline for applicant to respond to Commission Staff's recommendation on final disposition	December 29, 2023
Deadline for Commission Staff's recommendation on final disposition	January 5, 2024
Deadline for parties to submit proposed findings of fact, conclusions of law, and ordering paragraphs	January 19, 2024

III, PRAYER

WHEREFORE, PREMISES CONSIDERED, the Parties respectfully pray that the Commission ALJ extend the procedural schedule consistent with this pleading.
