- STAFF 2-1** The collection line and connection cost to provide continuous and adequate sewer service to the 1,917 proposed LUE's in the requested area pursuant to the capital improvement plan in interchange item 6 page 6 of this docket.
- STAFF 2-2** A firm capital commitment such as executed developer agreements, line of credit, equity agreements, sufficient cash reserves per audited financial statements, or loan documents affirming access to funds to pay for the required collection lines and connection cost provided in response to Staff 2-1 and pursuant 16 TAC § 24.11(e)(5)(B).
