#### JOINT REQUEST FOR EXTENTION

#### I. INTRODUCTION

On December 16, 2022, Forest Glen filed an application to amend its sewer certificate of convenience and necessity (CCN) No. 21070 in Medina County.

On December 18, 2023, the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed their Second Request for Information (RFI) seeking certain information from Applicant with a deadline of January 8, 2023. On November 15, 2023, the administrative law judge (ALJ) filed Order No. 11, directing Commission Staff to file a final recommendation on the application by January 5, 2023. Therefore, this pleading is timely filed.

#### II. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff is seeking clarification as well as additional information needed for a final recommendation and has issued a second RFI, which requires the collection of certain documentation from outside parties for which Applicant needs additional time. Accordingly, Staff will need additional time to prepare its final recommendation as the recommendation relies upon information requested by the second RFI. Therefore, Staff and Forest Glen (collectively, the Parties) jointly request that the procedural schedule in this docket be adjusted as follows:

Deadline for Commission Staff's recommendation on final disposition	February 2, 2024
Deadline for parties to submit proposed findings of fact, conclusions of law, and ordering paragraphs	February 16, 2024

#### III. CONCLUSION

Staff respectfully requests the entry of an order extending the deadlines in this proceeding as described above.
