REQUEST FOR EXTENSION

I. INTRODUCTION

On December 16, 2022, Forest Glen filed an application to amend its sewer certificate of convenience and necessity (CCN) No. 21070 in Medina County.

On December 18, 2023, the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed their Second Request for Information (RFI) seeking certain information from Applicant with a deadline of January 8, 2023. On December 27, 2023, Forest Glen filed its response to Staff's Second RFI. On January 8, 2024, the administrative law judge (ALJ) filed Order No. 12, directing Commission Staff to file a final recommendation on the application by February 2, 2024. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff will be filing a third RFI concurrently with this request for extension seeking clarification as well as additional information from the Applicant. Accordingly, Staff will need additional time to prepare its final recommendation as the recommendation relies upon information requested by the Staff. Therefore, Staff requests that the procedural schedule in this docket be adjusted as follows:

Deadline for parties to submit proposed findings of fact, conclusions of law, and ordering paragraphs	March 18, 2024

III. CONCLUSION
