APPLICATION OF FOREST GLEN UTILITY COMPANY TO AMEND ITS CERTIFICATE OF CONVENIENCE AND NECESSITY IN MEDINA COUNTY PUBLIC UTILITY COMMISSION

OF TEXAS

JOINT CLARIFICATION TO ORDER NO. 15

I. INTRODUCTION

On December 16, 2022, Forest Glen Utility Company (Forest Glen) filed an application to amend its sewer Certificate of Convenience and Necessity number 21070 in Medina County, Texas under Texas Water Code §§ 13.242 through 13.250 and 16 Texas Administrative Code §§ 24.225 through 24.237. A joint motion to admit evidence and proposed notice of approval was filed on March 18, 2024. An amended joint motion to admit evidence and proposed notice of approval was filed on March 19, 2024.

On April 9, 2024, the administrative law judge (ALJ) filed Order No. 15, directing Forest Glen and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) to clarify the omission of Staff's supplemental recommendation on sufficiency of notice, filed September 8, 2023, into the record and to file a motion to admit additional evidence, if necessary, by April 16, 2024.

II. CLARIFICATION AND REQUEST FOR EXTENSION

The Parties inadvertently omitted Staff's supplemental recommendation on sufficiency of notice, filed September 8, 2023, from the joint motion to admit evidence filed on March 18, 2024. The Parties request an extension to file their clarification and joint motion to admit additional evidence on April 25, 2024, alongside Forest Glen's response to Order No. 16.

III. CONCLUSION

The Parties respectfully request the ALJ grant the joint request for extension described above.
