REQUEST FOR EXTENSION

After Forest Glen Utility Company (Forest Glen) and the Staff of the Public Utility Commission of Texas (Commission) (hereinafter, parties) filed their Joint Motion to Admit Evidence and Proposed Notice of Approval and Amended Joint Motion to Admit Evidence and Proposed Notice of Approval on March 18 and 19, 2024 respectively, the Commission Administrative Law Judge (ALJ) directed the parties to address the inclusion of additional evidence into the record for this proceeding. On April 12, 2024, the Commission ALJ issued Order No. 16 requesting further clarification by the parties. The parties clarified in a filing on April 19, 2024 that they would be further modifying the Amended Joint Motion to Admit Evidence and Proposed Notice of Approval in a separate, future filing. On April 22, 2024, treating the parties previous filing as a request for extension, the Commission ALJ issued Order No. 17 establishing a deadline of May 9, 2024 to file a Joint Motion to Admit Evidence and Proposed Notice of Approval addressing the points of clarification. After reevaluating the scope of issues to be addressed in this docket as a result of the Commission ALJ's orders, the parties need additional time to finalize their Second Amended Motion to Admit Evidence and Proposed Notice of Approval, including map and revised tariff.

Accordingly, the parties request a short extension until May 17, 2024 to file the requested motion and exhibits. The parties do not foresee the need to extend any more deadlines set by the Commission ALJ. Forest Glen conferred with the Commission Staff who agree to and join in this filing.

The parties respectfully request that the Commission ALJ extend the deadline for filing the revised Joint Motion to Admit Evidence and Proposed Notice of Approval until May 17, 2024.
