I. BACKGROUND

On October 8, 2024, the Commission administrative law judge (ALJ) issued Order No. 20 requiring additional clarification and a new motion to admit evidence concurrent with Commission Staff's final recommendation of November 1, 2024. Therefore this pleading is timely filed.
