**JOINT CLARIFICATION TO ORDER NO. 21**

**I. INTRODUCTION**

On December 16, 2022, Forest Glen Utility Company (Forest Glen) filed an application to amend its sewer certificate of convenience and necessity number 21070 in Medina County, Texas under Texas Water Code §§ 13.242 through 13.250 and 16 Texas Administrative Code §§ 24.225 through 24.237. A third amended joint motion to admit evidence was filed on November 1, 2024.

On November 15, 2024, the administrative law judge filed Order No. 21, directing Forest Glen and the Staff (Staff) of the Public Utility Commission of Texas (collectively, the Parties) to clarify whether they are asking for the map and certificate as attached to Staff's revised final recommendation, filed on November 1, 2024, to be admitted as evidence by November 20, 2024. Therefore, this pleading is timely filed.

**II. CLARIFICATION**

The Parties clarify that Item 2 in the Third Amended Motion to Admit Evidence should be as follows, to include the memos, certificate and map attached to Staff's revised final recommendation:
