COMMISSION STAFF’S REQUEST FOR RULING

On January 4, 2023, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Valley Vista Homeowners Association, Inc. (Valley Vista) (collectively, the Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Uvalde County under the provisions of Texas Water Code § 13.301 and 16 Texas Administrative Code (TAC) § 24.239.

On July 28, 2023, the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed a recommendation on the sufficiency of the Applicants’ supplemental proof of notice and proposed a procedural schedule for further processing. In that procedural schedule, Staff included a deadline of August 18, 2023 for the Commission to make a determination to hold a hearing to give the parties more time to make additional filings necessary for the Commission to approve the sale. However, that 120 day deadline is contingent on Staff’s recommendation on the supplemental proof of notice. Accordingly, Staff requests a ruling on the sufficiency of the supplemental proof of notice. Furthermore, Staff respectfully requests the entry of an order making a determination to hold a hearing and adopting the proposed procedural schedule.
