ORDER NO. 16 FINDING CLOSING DOCUMENTATION, AS SUPPLEMENTED, SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the closing documentation filed by CSWR-Texas Utility Operating Company, LLC, TB GP, LLC dba Valley Vista Water Company, and Valley Vista Homeowners Association, Inc. dba Valley Vista Water Company (collectively, Valley Vista Water). On December 4, 2023, the applicants filed an executed general assignment and bill of sale. The applicants additionally asserted that there are no outstanding customer deposits associated with the water system at issue in this proceeding. On December 20, 2024, applicants supplemented the closing documentation with the following: (a) the affidavit of Thomas L. Kirkpatrick, former manager of TB GP; (b) an executed bill of sale; (c) an executed general assignment; and (d) special warranty deeds.

On January 16, 2023, Commission Staff filed a revised recommendation regarding the sufficiency of the closing documentation, as supplemented, and customer deposits.

The administrative law judge finds the closing documentation, as supplemented, sufficient and that there are no outstanding customer deposits to be addressed.
