## ORDER NO. 5 FINDING APPLICATION ADMINISTRATIVELY COMPLETE, REQUIRING NOTICE, ESTABLISHING A PROCEDURAL SCHEDULE, AND RESTLYING

This Order addresses the sufficiency of the January 4, 2023 application of Texas Water Utilities LP for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Montgomery County.

On March 10, 2023, Commission Staff filed a recommendation regarding the administrative completeness of the application and notice. Commission Staff additionally proposed a procedural schedule and requested to restyle this proceeding.

The administrative law judge (ALJ) finds the application administratively complete and, under 16 Texas Administrative Code § 24.239(c)(4), waives published notice because the requested areas do not include any unserved areas. The ALJ directs the applicants to provide notice of the application in the manner described in Commission Staff's March 10, 2023 recommendation. Notice must be provided using the forms attached to Commission Staff's March 10, 2023 recommendation and include the proposed bill insert filed as an attachment to the applicants' March 9, 2023 request for waiver of published notice and supplemental invoices.

The ALJ establishes the following procedural schedule:
