#### COMMISSION STAFF'S WITHDRAWAL OF STAFF'S SECOND REQUEST FOR INFORMATION STAFF 2-1 TO TEXAS WATER UTILITIES, LP

### I. INTRODUCTION

On January 4, 2023, Texas Water Utilities, LP (TWU) and Woodland Oaks Utility, LP (Woodland Oaks) (collectively, the Applicants) filed an application for the sale, transfer, or merger (STM) of facilities and certificate rights in Montgomery County under the provisions of Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239.

On April 27, 2023, Staff (Staff) of the Public Utility Commission of Texas (Commission) filed its second request for information to TWU.

# II. REQUEST TO WITHDRAW COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION

Staff has conferred with TWU regarding Staff's second request for information (RFI) Staff 2-1 to TWU. Following discussions, TWU has clarified that there are no improvements or construction needed to provide continuous and adequate service and that TWU therefore has no responsive information to Staff 2-1.
