Dear Judge Ta:

The memorandum of Jolie Mathis supporting Commission Staff's Recommendation on Administrative Completeness and Proposed Notice and Proposed Procedural Schedule (Recommendation), filed on March 10, 2023, recommended that notice of the application be provided to: (1) cities, districts, and neighboring retail utilities; (2) the county judge; and (3) each groundwater conservation district in the requested area; and (4) affected customers or other affected parties. Order No. 5, issued on March 13, 2023, directed the applicants to "to provide notice of the application in the manner described in Commission Staff's March 10, 2023 recommendation." On March 31, 2023, Texas Water Utilities, L.P. (TWU) filed the affidavit of Brian D. Bahr, Director of Rates and Regulatory Affairs for TWU, affirming that notice was provided on March 21, 2023 to the entities listed in Commission Staff's Recommendation, consistent with Order No. 5. TWU supplemented this filing with a confidential list of customers who were provided notice. In Order No. 6 issued on April 17, 2023, this notice was found sufficient.

Pursuant to orders issued in other pending TWU sale, transfer, or merger dockets,¹ TWU is providing supplemental proof of notice in the form an affidavit confirming that there are no tracts of land of at least 25 acres that are wholly or partially included in the area to be transferred to TWU. The requested supplemental proof of notice is provided herewith. TWU will include this supplemental proof of notice in the motion to admit evidence that is due to be filed in this proceeding on June 16, 2023.
