**SUPPLEMENTAL JOINT MOTION TO ADMIT EVIDENCE**

**I. INTRODUCTION**

On January 4, 2022, Texas Water Utilities, L.P. (Texas Water) and Woodland Oaks utility Company, Inc. (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Montgomery County under the provisions of Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. Texas Water filed supplemental information on May 1, May 2, and June 15, 2023.

On May 31, 2023, the administrative law judge (ALJ) filed Order No. 9, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission), Applicants, and the Office of Public Utility Counsel (collectively, the Parties) to file a joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed by June 16, 2023. The Parties timely filed a joint motion to admit evidence and a joint proposed order approving the sale and allowing the transaction to proceed; however, Staff filed a supplemental recommendation on final disposition and on the name change request to correct an error on July 6, 2023. Therefore, the Parties file this supplemental joint motion to admit evidence.

**II. SUPPLEMENTAL JOINT MOTION TO ADMIT EVIDENCE**

The Parties move to admit Staff's supplemental recommendation on final disposition and on the name change request, along with the attachment, filed on July 6, 2023 (AIS Interchange No. 48).

### **III. CONCLUSION**

For the reasons stated above, the Parties respectfully request that the ALJ grant the supplemental joint motion to admit evidence and grant the joint motion to admit evidence and adopt the joint proposed order filed on June 16, 2023.
