AFFIDAVIT AND CCN TX WATER CODE SEC 13.257 STATE OF TEXAS, COUNTY OF TRAVIS



"My name is George Freitag. I am the Regulatory Manager for Texas Water Utilities, L.P. (TWU). I am capable of making this affidavit. I am over 21 years of age, have personal knowledge of the facts herein set out, and am fully qualified to make this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct."

- TWU's primary business is providing retail water and wastewater utility services. It is the service provider of water and wastewater for various service areas in the State of Texas including but not limited to Montgomery County.
- TWU is the holder of water Certificate of Convenience and Necessity (CCN) No. 12983 and wastewater CCN No. 20899.
- On May 23, 2024, the Public Utility Commission of Texas approved the application of TWU and Woodland
 Oaks Utility LP (Woodland Oaks) for sale, transfer, or merger of facilities and certificate rights and for a
 name change to certificates of convenience and necessity in Montgomery County in Docket No. 54546.
- 4. The water CCN area transferred to TWU from Woodland Oaks is approximately 884 acres and is located approximately 8.4 miles southwest of downtown Conroe, Texas, and is generally bounded on the north by Honea Egypt Road, on the east by Honea Egypt Road, on the south by Farm-to-Market Road 1488, and on the west by Pipestone Road.
- 5. The sewer CCN area transferred to TWU from Woodland Oaks is approximately 737.6 acres and is located approximately 8.4 miles southwest of downtown Conroe, Texas, and is generally bounded on the north by County Road 2629, on the east by Westwood Drive, on the south by the intersection of Tamina Road and Revelwood Drive, and on the west by Corporate Woods Drive.
- This filing supersedes any previous filings by TWU of certified maps showing its water and sewer service area in Montgomery County.
- This affidavit contains as attachments the certified maps showing the water and sewer service area in Montgomery County, Texas.
- This affidavit will be filed and recorded in the Real Property Records of Montgomery County, Texas, pursuant to Section 13.257 (r) and (s) of the Texas Water Code.




