LUBBOCK POWER & LIGHT'S 2022 "4CP" DATA FOR LOAD TO BE INTEGRATED INTO THE ERCOT REGION

The City of Lubbock, acting by and through Lubbock Power & Light (LP&L), files this 2022 "4CP" data for load to be integrated into the ERCOT Region.

In Ordering Paragraph 8 of the Commission's Order in Docket No. 53529, the Commission ordered LP&L to "calculate and provide ERCOT and the Commission LP&L's four-coincident-peak data for the remaining load for the calendar year before its expected integration date as soon as the data is available but not later than 14 days before the integration date..." Information responsive to Ordering Paragraph 8 is contained in the chart below:²
