I understand fully the cost of many things are increasing including utilities such as water and electricity as well as the basic cost living and gasoline. I can understand prices are are up on prettyu much everything these days. I cannot though how you could possibly more than double our cost for such an essential thing as water. I would understand and wouldn't mind a moderate rate increase based on current economical situation knowing that the basic costs of operation are rising. My wife and I are in our sixties and on limited income. We both sill work as well to make ends meet. Doubling our cost of water seems extreme under the current situation. We have two meters, one of which we haven't used since the big ice storm we had a couple years ago which froze and burst the pipes on lot 22. Our other meter is on lot 20 where we currently reside. We have been living out here since 1994 and our water quality has been poor. There are many weekenders out here and summer vacationers. When everyone shows up our water has always gotten cloudy even muddy looking at time. The previous owners of the facility always said it was due to sediments in the lines being stirred up from high water usage. We were always told nothing could be done about. We have lived with this condition since 1994. The more people that show up out here the worse our water quality gets. We have seen no improvements to any of the water facilities except for repairs being made on lines that break. I think its outrageous for you to consider over doubling our cost for water with such poor water conditions. The annual increase of \$286,417.00 seems even more outrageous. We are getting new bills from you now which don't even have accurate water usage only estimates. Why are we only getting estimates? We have learned to live with the poor water quality but I just don't see having to pay over double for bad water!
