**MOTION TO INTERVENE OF
THE DOMINION HOMEOWNERS ASSOCIATION**

The Dominion Homeowners Association (“Dominion”) moves to intervene in this docket pursuant to Tex. Water Code § 13.301 and 16 Tex. Admin. Code (“TAC”) § 22.103.

I. Background

On February 3, 2023, CSWR-Texas Utility Operating Company, LLC (“CSWR”) applied for Public Utility Commission of Texas (“Commission”) approval of a rate increase for water and wastewater service for its Texas customers, including those customers who are members of Dominion. According to information provided by CSWR, sewer rates for the Leon Spring wastewater system would increase from \$21.56 per month to \$66.65 per month if the Commission were to grant the requested increase.

Dominion is an association that exists to represent the interests of homeowners in the Dominion subdivision, all of which will be adversely affected by the outcome of this proceeding if CSRW is allowed to raise rates for wastewater service.

For these reasons, Dominion requests that the Commission grant this Motion to Intervene and admit Dominion as an Intervenor for all purposes. Dominion further requests any other relief to which it may be entitled.
