After reading the notification received from CWSR concerning a significant rate increase, approximately 100%, it appears that we are being charged for all upgrades throughout the system not just our area. Before any increase is approved, we would like to have a representative from the CWSR management team schedule a meeting in Aransas County to provide detailed information to answer what the increase is paying to justify the rate increase.

At the very least, we would like to request a detailed explanation providing this information not just general information of what has been done or plan to do in the state of Texas. And some type of forecast for the future. If there is to be an increase, we would ask that it be a reasonable % increase.
