RATEPAYER COMMENTS/REQUESTS TO INTERVENE

I am a property owner of two lots within the Tri-County Property Owners Association (TCPOA). CWS seeks to almost double the prices for water and sewage on these properties.

CWS purchased the water and sewer service from TCPOA within the last year. The purchase price that was paid by CWS to TCPOA was discounted because of the operational and facility issues that were known at the time or discoverable with adequate due diligence.

If the extreme rate increase sought by CWS currently is granted the property owners will effectively be paying twice for the remediation of the facilities that were already discounted from the purchase price. The term Buyer Beware should not become the property owners' issue.

A reasonable increase due to cost of operations is possibly merited, but this rate case should be carefully examined to ensure that CWS is not granted a windfall of recovering twice.
