I am writing regarding the above referenced docket number relating to proposed water rate increases by CSWR-Texas. I am very concerned about how the 100 percent requested increase in water rates will financially impact me and my neighbors. I am also concerned that the information that I received from CSWR-Texas isn't very clearly written, defined and transparent to the average citizen. Here are my concerns regarding the information I received from CSWR-Texas:

- In the cover letter water and waste water are mentioned we are all on septic systems
- They mention all the work they are doing at all the other locations in Texas which total up to 58 facilities but I believe any increase in my rate should be used for our system. Where on the list will we get upgrades, 10 years down the road? There wasn't a work plan for the proposed increase shared.
- On the Notice of Proposed Rate Change pages they seem conflicting to me. One page shows current/proposed rates for 5,000 and 10,000 gallons but on the next page where the gallonage charge current/proposed rates are it appears that proposed rate will be any usage from 1 to 10,000 gallons. This is confusing to me because it appears that 10,000 will be the standard usage charge. Where are the other tiers in here? So for a retired person with little water usage this is unfair.

Also, CSWR-Texas purchased the water system I am on (Grande Casa Well) from Carroll Water in May 2022. It is my understanding that there should be at the minimum a one year test year to evaluate accurately the need for a water rate increase. This timeframe has not been met nor do I think it has been accurately evaluated/investigated.

I am very concerned about the financial impact, should it occur, will make on me and my neighbors. I am planning on retiring soon and will be on a fixed income and this is concerning. I understand that the cost of business has risen but not by a 100 percent increase. I strongly request that the PUC not let this happen.

In closing, I am formally requesting that PUC and CSWR-Texas hold a meeting for my community and clearly explain the process to make it transparent as to what is going on. I need to understand the process, have time to comment and know what my rights are. Should you have any questions or need to contact me I can be reached at 214-212-1732.
