This letter is in regard to the rate filing request submitted by CSWR-Texas on 2/3/2023 for the purposes of raising water/sewer rates for Laguna Tres and Laguna Vista subdivisions near Granbury Texas.

My wife and I reside in Laguna Tres subdivision and, like many of our neighbors, live on a small fixed income. We are writing this letter to protest the request by CSWT-Texas. The rate increase of 240% for water, 81% for minimum monthly charge, and an additional 2.15% of water used increase for pass through charges, plus 267% increase for sewer charges is way out of line anytime much less now when inflation has a strong grip. We hope that you see the ridiculousness of these requests and do what is best for the people of Texas and deny this abuse of new ownership of this utility company.
