No previous correspondence was provided by CSWR – Texas Management, as referenced in the letter received on February 28<sup>th</sup>, 2023. The date in the heading of the letter is February 3<sup>rd</sup> and states "we are providing a copy of the notice to you at the alternate address that we have on file for you, which is the same notice you should have received previously". This was received at our home address, which is the same as our billing address. Our water/sewer bills are received at this address; therefore, this notice should have been sent in a timely manner to the same location without error.

The proposed rate changes for the minimum monthly charge are greater than a **115 percent increase** for water. The proposed rate changes for the minimum monthly charge are greater than **120 percent increase** for sewer. Both are essential utilities. Customers' lives should not be negatively affected and financially impacted by such an extensive proposed increase in rates. Please help with this issue and protect this small Texas community from overt (out of state) price gouging. Thank you!
