Nearly doubling the billing cost 'To recover revenues sufficient to cover the cost to provide safe and

reliable service through maintenance and repairs' is ridiculous and suggests CSWR is attempting to recover losses from the past and/or pad future profits.

Not all services are the same as far as treatment. For example, our subdivision does not have wastewater treatment. We shouldn't be charged nor share the charges of people that utilize wastewater treatment.

The first page suggests that the request to increase billing is for many different 'improvement projects'. If these projects are not going to improve the facility for our subdivision, we shouldn't have to bear the costs for other facilities that don't serve us to be improved while we continue to utilize the same service we have been.

Again, requesting to nearly double the billing rates is ridiculous.
