CSWR – Texas – Timberlane Water System

Intervenors – Lewis and Donna Knowles Jr – 296 Timberlane Loop

Ratepayer comments/request to Intervene

We asked to be added as an intervenor during the Prehearing conference on June 15, 2023. This filing is a follow up to that conference.

My wife Donna and I have owned a vacation home at 296 Timberlane Loop, Hemphill, Texas 75948 for many years. We typically spend 25 weekends a year at this residence. The water we rely on for drinking/cooking/bathing/septic is provided by a water system now owned and operated by CSWR-Texas. It is referred to as the Timberlane System. We have been using less than 2000 gallons a month for years and paying \$35.35 per month. Since CSWR-Texas began providing us with water service our monthly bill has averaged \$36 to \$38 because it was based on existing rates. We feel this is acceptable.

We understand that CSWR wants to consolidate our 42-customer water system (Timberlane) with others CSWR has recently acquired and increase the water rates so that our typical 2000 gallons will cost about \$66. a month. We also understand that CSWR's rate increase will charge each customer \$54.03 for just being connected to the water system, if they use water or not. We feel this is unacceptable.

Whereas, CSWR-Texas has spent some monies on cleaning up the pumphouse area, replacing our water meter, just recently making repairs on a few mainline water leaks that have been leaking since the first of the year, and reportedly updating monitoring of the pumps/wells/generator, they are not expected to make any major/costly improvements/repairs to Timberlane system in the future. The efforts to date were to help them pass TCEQ inspection. Thus, the additional revenue they request from the Timberlane system customers will be spent on other systems they have acquired.

First off while we are not in favor of consolation of all their water systems, if this is a cost-effective approach to providing safe and reliable water to all of their customers, then so be it. We trust that staff will so determine if this is legal and cost effective for all.

Secondly an increase as proposed prior to making improvements to the Timberlane system to provide the safe, high quality and reliable water seems to be putting the cart before the horse. We understand the PUC process requires public utilities to justify increases based on cost of improvements already made. Asking for increase in revenues with no assurances that improvements will be made seems risky. It is well

known that you do not pay for your improvements before you have them made. To many contractors/companies have taken the money and run.

Further, we never received from CSWR of their notice of the rate increase. We were just recently made aware of the pending matter upon receipt of the Prehearing Conference letter that was held by Zoom on June 15, 2023. Fortunately, one of our neighbors set up Zoom so that some 16 or so could enter our request to intervene during that hearing.

As requested in the hearing, we have now completed and filed The Ratepayer Comments/Request to Intervene form was provided to us by a neighbor in Timberlane.

In closing, we request that the Judges and staff will do what is right to protect the interest of the customers of CSWR – Texas from unjustifiable and unreasonable increases in rates at this time. We also ask that they first make improvements to provide the safe and reliable water to their customers and then circle back to ask for additional revenues.
