Affected communities have been notified that it will require a minimum 895 responses for the matter to be set for hearing.

The communities of Copano Cove and Copano Ridge as specified in the notice accompanying the Ratepayer comments/requests to Intervene form are made up of a very large number of residents that are either winter visitors or part-time residents. This has increased in number since Harvey nearly wiped our city of Rockport off the map in 2017

After personally checking with four (4) properties, across the street, used part-time the following addresses were not sent the notice of intent:

619 Copano Cove Road

621 Copano Cove Road

623 Copano Cove Road

It is going to be incredibly difficult to reach the 895 responses required from our small communities when so many property owners are not being given the opportunity to respond. These four (4) are not isolated occurrences. Others are reporting the same on their streets.
