We protest the proposed rate increase for Tri-County water systems in Palacios, Texas. Most of the rate payers (greater than 50%) in this community are not fulltime residents. Most of rate payers use this service on a part time basis for RV camping. Also, most of the fulltime residents are retired and on a fixed income.

We do not agree with \$120.68 base rate with zero gallons used. Rate increases should be limited to 5% annually or some reasonable number based on conditions.

Also, CSWR has not made one improvement to this system. It appears they are trying to collect funds before making any improvements. Show us actual money spent to justify rate increases.
