COMMISSION STAFF'S REQUEST FOR AN EXTENSION

I. INTRODUCTION

On January 19, 2023, the City of Pflugerville (Pflugerville) filed an application to amend its certificate of convenience and necessity (CCN) number 20678 and to decertify Kelly Lane Utility Company Inc.'s (Kelly Lane) CCN number 20720 in Travis and Williamson Counties. Pflugerville supplemented the application on February 21, 2023, May 1, 2023, June 5, 2023, and June 23, 2023.

On July 12, 2023, the administrative law judge (ALJ) filed Order No. 6, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice and supplemental notice and propose a procedural schedule by August 22, 2023. Therefore, this pleading is timely filed.

II. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is waiting for Pflugerville to notify additional landowners to fully satisfy all of the notice requirements specified in Order No. 4. To allow enough time for Pflugerville to notify additional landowners and file all required documents and for Staff to review, Staff respectfully requests the entry of an order extending the deadline for Staff to file the above-described recommendation to September 19, 2023.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to September 19, 2023, to file its recommendation on the sufficiency of notice and supplemental notice and to propose a procedural schedule for further processing of the docket.
