ORDER NO. 8 FINDING NOTICE, AS SUPPLEMENTED, SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of notice and supplemental notice provided by the City of Pflugerville.

On May 1, 2023, Pflugerville filed (1) the affidavit of Brandon Pritchett, director of public utilities of Pflugerville, attesting that direct mailed notice, along with maps, was sent to current customers, landowners, neighboring utilities, and affected parties on April 10 or 11, 2023; and (2) a publisher's affidavit attesting to the publication of notice in the *Austin American Statesman*, a newspaper of general circulation in Travis and Williamson counties, on April 12 and 19, 2023.

On June 5, 2023, Pflugerville filed the affidavit of Mr. Pritchett, attesting that notice was provided to the listed landowners on June 1, 2023.

On June 23, 2023, Pflugerville supplemented the June 5, 2023 affidavit, with a copy of the Travis and Williamson counties central appraisal district maps overlaid on the requested area with the list of landowners and a list of landowners with addresses and acreage.

On August 29, 2023, Pflugerville filed the affidavit of Mr. Pritchett, attesting that notice was provided to landowners on August 25, 2023. The affidavit attached a copy of the notice, and Travis and Williamson counties central appraisal district maps overlaid on the requested area with the list of landowners and a list of landowners with addresses and acreage.

Finally, on September 14, 2023, Pflugerville filed a supplemental affidavit confirming that notice was provided to Valient Residential and Amanda Kay Roberson on April 10 and August 25, 2023, respectively.

On September 19, 2023, Commission Staff filed a recommendation regarding the sufficiency of the notice and supplemental notice and proposed a procedural schedule for continued processing.

The administrative law judge finds the notice, as supplemented, sufficient.

The following procedural schedule is established for continued processing:

Deadline for Pflugerville and Kelly Lane Utility to file signed consent forms with the Commission	November 6, 2023
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	November 15, 2023
Deadline for parties to file a response to Commission Staff's recommendation	November 22, 2023
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	November 29, 2023
