- 13. Commission Staff's final recommendation and request for good cause exception and all attachments filed on November 15, 2023;
- 14. The final proposed map and certificate, attached to the joint motion to admit evidence and proposed notice of approval, filed on November 29, 2023; and
- 15. Commission Staff's clarification filed on January 12, 2024.
