**ORDER NO. 3**  
**FINDING APPLICATION, AS SUPPLEMENTED, ADMINISTRATIVELY**  
**COMPLETE, REQUIRING NOTICE, ESTABLISHING**  
**PROCEDURAL SCHEDULE, AND RESTYLING**

This Order addresses the administrative completeness of the City of Pflugerville's January 19, 2023 application to amend its certificate of convenience and necessity (CCN) number 20678 and to decertify Kelly Lane Utility's CCN number 20720 in Travis and Williamson counties. On February 21, 2023, Pflugerville filed a supplement to the application.

On March 23, 2023, Commission Staff filed a recommendation on administrative completeness, provided instructions and forms for providing notice, and proposed a procedural schedule.

The administrative law judge (ALJ) finds the application, as supplemented, administratively complete and directs the Pflugerville to provide notice of the application as described in the March 23, 2023 memorandum of Jaspinder Singh attached to Commission Staff's recommendation, using the included forms.

The ALJ adopts the following procedural schedule:

Deadline for applicant to file with the Commission signed affidavits that the notice was given along with a copy of the notice and map sent to the affected parties and published in a newspaper of general circulation	May 8, 2023

Deadline for Commission Staff to file a recommendation on sufficiency of notice, including whether the applicant has provided service to all landowners within the requested area, and whether notice to all landowners, regardless of acreage, is required	May 22, 2023
Deadline to intervene	30 days after last date notice is issued
