EL PASO ELECTRIC COMPANY'S PROPOSED LIST OF ISSUES

El Paso Electric Company (EPE) submits the following proposed list of issues to be addressed in this docket in response to the Commission's Second Order Requesting Lists of Issues dated September 22, 2023.

- 1. Is EPE's proposed new tariff for its EV Smart Rewards Pilot Program reasonable and otherwise consistent with statutory requirements and Commission rules?
- 2. Is EPE's proposed new tariff for its Whole House EV Pilot Incentive Credit Rider reasonable and otherwise consistent with statutory requirements and Commission rules?
- 3. Is EPE's proposed new tariff as amended on September 22, 2023 for its PowerConnect Pilot Program reasonable and otherwise consistent with statutory requirements and Commission rules?
- 4. Is EPE's proposed new tariff as amended on September 22, 2023 for its Take Charge TX Pilot Program reasonable and otherwise consistent with statutory requirements and Commission rules?

EPE identified the following as an issue not to be addressed in this docket because the issue has been addressed by the newly passed legislation SB1002.

1. Is it appropriate for an electric utility in a vertically integrated area to own vehicle charging facilities or other transportation electrification and charging infrastructure, or should the ownership of such facilities be left to competitive providers?

EPE has not identified any threshold issues requiring briefing.

EPE respectfully requests that the Commission issue a preliminary order adopting this list of issues.
