Each GRANTOR hereby covenants with Grantee that such Grantor is the lawful owner of the respective Property and that such Grantor has good right to sell the same as aforesaid, that the respective Property is free from all encumbrances, liens, security agreements or charges, and that such Grantor will warrant and defend the sale of the respective Property against the lawful claims and demands of all persons whomsoever.

This Bill of Sale shall be construed under and enforced in accordance with the laws of the State of Texas.
