TO WHOM IT MAY CONCERN

We request to intervene in this sale for the purpose to seek a just treatment of all customers within Southern Crossing and Southern Oak subdivisions.

Southern Horizons Development, Inc. has failed both subdivisions and should not be awarded with a sell off but held accountable. This company had and has numerous compliance failures. Pipes are failing, chlorine level and pressure fluctuate, non functioning shutoff valves, billing from 25 to 35 days etc..

Southern Horizons Development has currently two pending enforcement actions with TCEQ, Docket No. 2020-0210-PWS-E Case No. 58898 and Docket No. 2022-0493-PWS-E Case No. 62270. These cases, according to TCEQ Enforcement, will not be transferred to the new entity Texas Water Utilities. L.P. These cases are vital to keeping water companies accountable for there lack of customer service and failure on the upkeep of the water distribution systems which is in deplorable condition (my line approx. 60', alone, has 4 repairs).

If Texas Water Utilities L.P. should succeed, with the purchase, they at least should not be authorized to force their Water Tariff Rate on to their new customers. They should honor the existing rates or show proof of an improvement plan to the water distribution system.

Most of the Customers in both subdivisions are low or fixed income. The new rates will greatly influence all of us (at least \$20 per month more) with no change or upgrade to the distribution system.
