Dear Judge Ta:

In its supplemental proof of notice filed in this docket on May 9, 2023, Texas Water Utilities, L.P. (TWU) indicated in a statement signed by Brian Bahr, Director of Rates and Regulatory for TWU, that there were no tracts of land greater than 25 acres located wholly or partially within the requested CCN area. Order No. 7, issued in this proceeding on May 24, 2023, established a deadline of June 7, 2023 for TWU to file an affidavit stating that notice has been mailed by first-class mail to each owner of a tract of land that is at least 25 acres and is wholly or partially included in the area proposed to be certified, a copy of applicable appraisal district maps overlaid with the requested area, a list of the landowners with properties wholly or partially in the requested area and the acreage owned by each listed owner, and, if applicable, an affidavit that there are no landowners with a 25-acre or more tract of land that is wholly or partially included in the requested area. BEFORE ME, the undersigned authority, on this day personally appeared Brian Bahr, who being by me first duly sworn, on oath deposed and said the following:

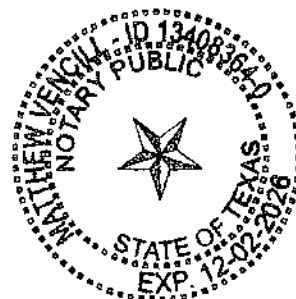

6. I affirm that the information submitted in this affidavit is true and accurate.

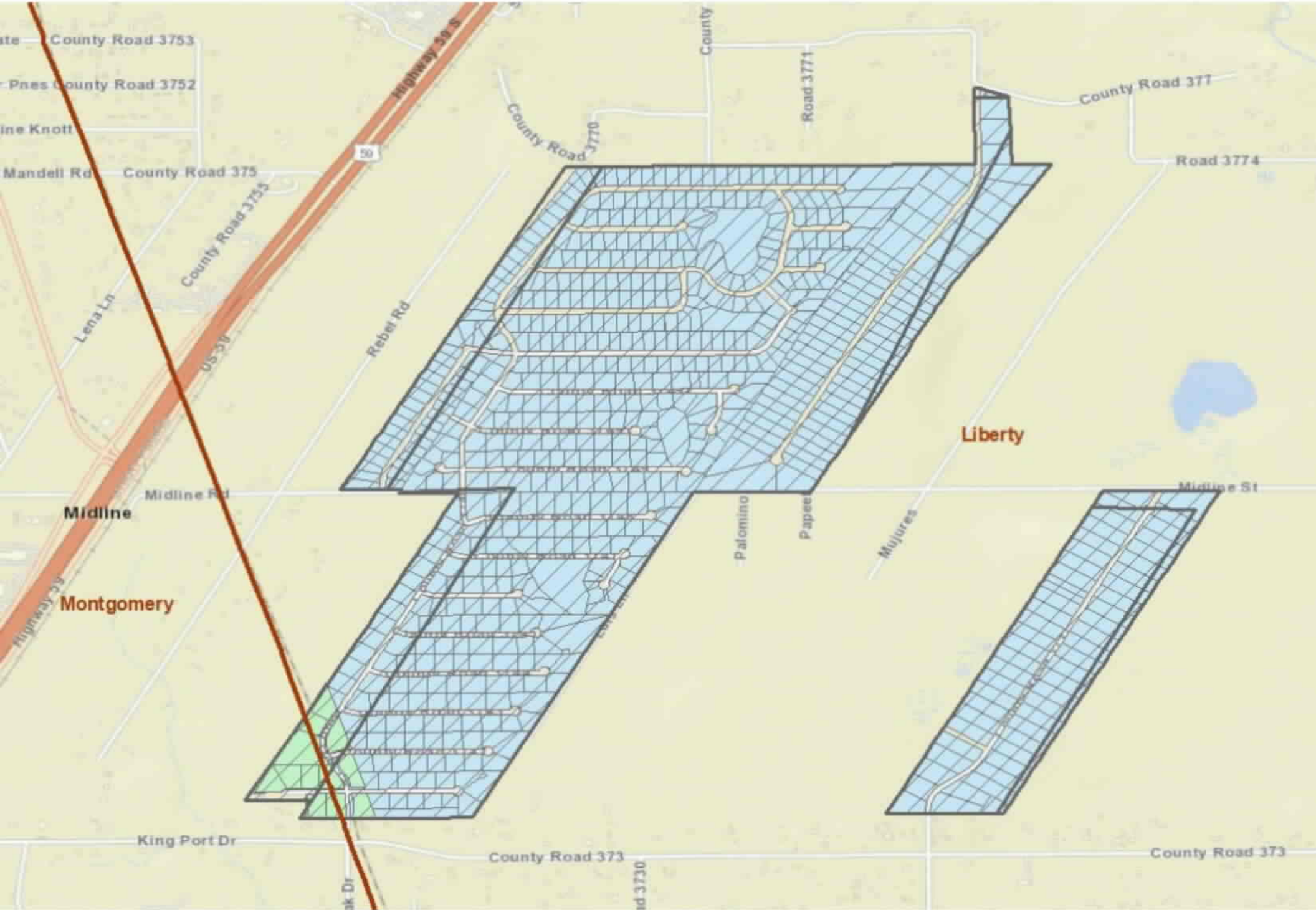
