## ORDER NO. 9 FINDING NOTICE SUFFICIENT AND ADOPTING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice of Texas Water Utilities, LP and Southern Horizons Development, Inc.'s application for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Liberty and Montgomery counties.

On April 26, 2023, Texas Water Utilities filed the affidavit of Brian Bahr, Texas Water Utilities' director of rates and regulatory affairs, attesting that notice of the application was provided to current customers, landowners, neighboring utilities, and affected parties on April 20, 2023. On May 9, 2023, Texas Water Utilities filed a publisher's affidavit attesting to the publication of notice in the *Houston Business Journal*, a newspaper of general circulation in Harris, Liberty, and Montgomery counties, on April 21 and 28, 2023. On June 7, 2023, Texas Water Utilities filed the affidavit of Mr. Bahr attesting that there are no tracts of land greater than 25 acres located wholly or partially within the requested area.

On May 22 and June 21, 2023, Commission Staff filed recommendations regarding the sufficiency of notice.

The administrative law judge finds the notice sufficient and adopts the following procedural schedule.
