Texas Water Utilities, L.P. (TWU) respectfully requests that the Office of Policy and Docket Management treat the motions filed in Docket Nos. 54617 and 55157 on December 21, 2023 as timely filed per the attached email confirmations.

On December 21, 2023, TWU filed a Motion for Reconsideration of the Commission's Decision to Table Consideration in Docket Nos. 54617 and 55157 using the Interchange Filer. Per the attached email confirmations, both filings were received at **2:51 p.m.**

When these filings were not processed and accepted by Central Records within the usual timeframe for filings of this type, my paralegal, Hanna Campbell, called to inquire as to the reason. Ms. Campbell was told by a clerk in Central Records that the server was experiencing issues, and that there was a backlog of filings made on December 21, 2023, that would be processed and posted to the Interchange later in the afternoon.
