## SOAH ORDER NO. 3 SCHEDULING HEARING ON THE MERITS

1. **Procedural Schedule**. On April 1, 2024, Texas Water Utilities, LP. on behalf of itself Southern Horizons Development, Inc. (Applicants), and the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed an agreed proposed procedural schedule. Office of Public Utility Counsel (OPUC) filed an alternate schedule. The ALJ adopts Applicants' and Staff's schedule, but omits reference to striking intervenors. The Schedule is adopted as follows:

## In addition:

- 1. Testimony drafts and the emails transmitting them are not discoverable.

- 3. Any party that does not file Direct Testimony may not file Cross-Rebuttal Testimony.
- 5. Intervenors may only file cross-rebuttal addressing Staff's Direct Testimony and the Direct Testimony of other Intervenors and Staff may only file cross-rebuttal addressing Intervenors' Direct Testimony.
- 6. Discovery requests received after 3:00 p.m. are deemed to have been received the following business day.

- 7. For discovery requests on Intervenor Direct Testimony, Staff Direct Testimony, Applicants' Rebuttal Testimony, and Cross-Rebuttal Testimony:
  - a. Objections are due within five calendar days of the date the request is received.
  - b. Motions to compel are due within three working days of the date the objection is filed.
  - c. Responses are due within 10 calendar days of the date the request is received.
- 2. Hearing. A hearing will be held at 9:00 AM (CT) on July 23, 2024, remotely via Zoom videoconference. 1 Tex. Admin. Code § 155.405(c). The audio portion of the hearing will be recorded, and it will be the official record of the proceeding. Attend the hearing in one of these ways:
